

## Resolution No. 110/2017 of the Chief Executive Officer of the Budapest Stock Exchange Ltd.

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') suspends exchange trading in the ordinary shares (ISIN: HU0000110226) of the issuer OPIMUS GROUP Nyilvánosan Működő Részvénytársaság (registered seat: 1065 Budapest, Révay u. 10. – hereinafter referred to as 'Issuer') on March 9, 2017 from the beginning of trading to the end of the Exchange Day on March 13, 2017.

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.

In the case such information is released prior to the end of the suspension period, the CEO may resolve to resume trading in the Issuer's ordinary shares.
