

## Extract from Resolution No. 210/2017 of the CEO of the Budapest Stock Exchange Ltd

Budapest, 8 June 2017

The Chief Executive Officer of the Budapest Stock Exchange (hereinafter: Exchange) declares that orders for shares of

- KONZUM Plc. (ISIN: HU0000142419, registered seat: 7621 Pécs, Irgalmasok u. 5.),
- OPIMUS GROUP Pic. (ISIN: HU0000110226, registered seat: 1065 Budapest, Révay u. 10.),
- FuturAqua Pic. (ISIN: HU0000107362, registered seat: 7623 Pécs, Megyeri út 25.),
- OTT-ONE Pic. (ISIN: HU0000149679, registered seat: 1024 Budapest, Fény utca 16. 5. em.),

subject to the limitations set by the General Terms of Service of the Budapest Stock Exchange Ltd. Book five – Regulations on Trading (hereinafter: Regulations on Trading) under section 13.3.4, on the exchange day of 9 June, 2017 will be modified to:

- bid prices may be up to 50% higher than the Base price;
- offer prices may be up to 50% lower than the Base price.

## Reason

The Exchange has considered that in the above shares the price movement limitations - set by the Regulations on Trading under 13.3.4 and CEO Resolution 550/2013 - are considered as insufficient for the following day's exchange trading.

Therefore, in order to ensure the smooth flow of trading the CEO of the Exchange decided accordingly.
