The purpose of the Parties with the said transaction is to mutually own 72,6647 percent of the partnership interests in **Mátrai Power Plant Closed Company Limited by Shares** (registered seat: 11. Erőmű street, HU-3271 Visonta; company registration number: 10-10-020024; tax ID.: 10729571-2-10; hereinafter: '**Mátrai Power Plant**').

Dated today, MÁTRA ENERGY HOLDING Ltd has concluded sale and purchase agreements on 72,6647 percent of the shares issued by, and embodying partnership interest in Mátrai Power Plant with **RWE Power AG** (registered seat: 45128 Essen, Huyssenallee 2, Germany; company registration number: HRB 17 420), **GBV Dreißigste Gesellschaft für Beteiligungsverwaltung mbH** (registered seat: 45128 Essen, Opernplatz 1, Germany; company registration number: HRB 27 109), **EnBW Trust EV** (registered seat: Durlacher Allee 93, Karlsruhe, Baden-Württemberg, 76131, Germany; company registration number: VR 103737), and **EnBW Energie Baden-Württemberg AG** (registered seat: 93 Durlacher Allee, 76131 Karlsruhe, German; company registration number: HRB 107956).
