



**Resolution No 62/2018 of the Chief Executive Officer of  
the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000110226) and related derivative instruments** (included in the Annex to this Resolution) **of the issuer OPUS GLOBAL Nyilvánosan Működő Részvénytársaság** (registered seat: HU-1065 Budapest, Révay u. 10.) . – hereinafter referred to as 'Issuer') **on February 15, 2018 from the beginning of trading to the end of the Exchange Day – until the end of the 'Post Trading phase' – on February 15, 2018.**

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.

In the case such information is released prior to the end of the suspension period, the CEO may resolve to resume trading in the Issuer's ordinary shares and related derivative instruments.
