



**Resolution No 87/2018 of the Chief Executive Officer of
the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000102132) and related derivate instruments** (included in the Annex to this Resolution) **of the issuer APPENINN vagyonekezelő Holding Nyilvánosan Működő Részvénytársaság** (registered seat: HU-1022 Budapest, Bég u. 3-5.) – hereinafter referred to as 'Issuer' – **on March 12, 2018 from 8:31 a.m. to the end of the Exchange Day – until the end of the 'Post Trading phase' – on March 12, 2018.**

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.

In the case such information is released prior to the end of the suspension period, the CEO may resolve to resume trading in the Issuer's ordinary shares and related derivate instruments.
