



**Resolution No. 246/2018 of the Chief Executive Officer of  
the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000102132) and related derivative instruments** (included in the Annex to this Resolution) **of the issuer APPENINN Vagyonkezelő Holding Nyilvánosan Működő Részvénytársaság** (registered seat: HU-1062 Budapest, Andrásfi út 59.) – hereinafter referred to as 'Issuer' – **on August 23, 2018 from 10:00 a.m. to the end of the Exchange Day – until the end of the 'Post Trading phase' – on August 23, 2018.**

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.
