



Resolution No. 268/2018 of the CEO of the Budapest Stock Exchange Ltd.

Budapest, September 12, 2018

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter: the CEO) has accepted the proposal of the Index Committee on the review and amendment of the CETOP basket as follows:

As of September 24, 2018, the Central European Blue Chip Index of the Budapest Stock Exchange will contain the following 25 equities:

In the case of Polskie Gornictwo Naftowe i Gazownictwo SA (PLPGNIG00014), the CEO – taking Point 3.9 c) of the Manual of CETOP Index into account – decided keeping the issuer's shares in the index basket instead of introducing Santander Bank Polska SA (PLBZ00000044) to the basket.

On September 12, 2018, the Exchange will inform the public about the new composition of the CETOP basket, as well as free float figures (FFi), the amounts of shares listed on the relevant exchange (Qi) and the weighting factors (WFi) of the share series included. On September 21, 2018, the Exchange will specify and publish the AF factor and on September 24, 2018 BSE will introduce the new basket.
