



**Resolution No. 323/2018 of the Chief Executive Officer of  
the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000160650) and related derivate instruments (included in the Annex to this Resolution) of the issuer KONZUM Investment and Asset Management Public Limited Company (registered seat: HU-1062 Budapest, Andrásy út 59.) – hereinafter referred to as 'Issuer' – on October 18, 2018 from the beginning of trading to the end of the Exchange Day – until the end of the 'Post Trading phase' – on October 18, 2018.**

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.

In the case such information is released prior to the end of the suspension period, the CEO may resolve to resume trading in the Issuer's ordinary shares and related derivate instruments.
