



**Extract from Resolution No. 126/2019 of the Chief Executive Officer of

The Chief Executive Officer of the Budapest Stock Exchange Ltd. resolved to **resume trading in the ordinary shares** (ISIN: HU0000154927) **of the issuer Első Hazai Energia-portfólió Plc.** (registered seat: HU-1163 Budapest, Cziráki u. 26-32. II. 144.) **on the Exchange day of May 3, 2019 from the Pre-trading phase.**

The CEO warns the Shareholders and Investors of the Issuer that the decategorisation of the ordinary shares will be continuously effective, therefore the trading model applied during the resumed trading of the Issuer's securities will be Auctions Trading Model.
