



**Resolution No. 146/2019. of the Chief Executive Officer
of the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends** the exchange trading of the securities named **Erste BMW Turbo Long 04 Warrant**, ticker symbol: **EBBMWTL04**, ISIN code: AT0000A23TZ4, issued by **Erste Group Bank AG** (Am Belvedere 1., A-1010 Wien, Austria) (hereinafter referred to as 'Issuer') **on May 23, 2019, from 9:09 a.m. for the remainder of the Exchange Day and remove the securities from the Product List** at the request of the Issuer.
