



**Resolution No 223/2019 of the Chief Executive Officer of the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000167788) and related derivate instruments** (included in the Annex to this Resolution) **of the issuer 4iG Nyilvánosan Működő Részvénytársaság** (registered seat: 1037 Budapest, Montevideo u. 8.) hereinafter referred to as 'Issuer' **on July 9, 2019 from the beginning of trading until the end of the "Post Trading phase" on July 9, 2019.**

The CEO obliges the Issuer to disclose the extraordinary information necessitating the suspension of trading in accordance with the Exchange regulations.

In the case such information is released prior to the end of the suspension period, the CEO may resolve to resume trading in the Issuer's ordinary shares and related derivate instruments.
