Pursuant to Section (1) of Paragraph 3 of Act CVI of 2007 on public assets (Vtv) MNV Zrt. exercises the totality of the ownership rights and obligations of the State over the public assets as the exerciser of the ownership rights, unless otherwise provided in a law or a Ministry decree.

Pursuant to the authorization granted by (2a) passage of Article 3 of the Property Act ("Vtv), the Minister Responsible for the Management of State Property is entitled to appoint an organization, operated from central budged sources, or a business company, wholly owned by the state, to exercise the ownership rights and meet the obligations, in whole or in part, over the state property in accordance with the Act of CXCV of 2011 on the state national budget. Such appointment shall be in accordance with the purpose of achieving the goals more efficiently determined under Article 2 of Vtv. Such appointment shall be in accordance with the decree issued by the relevant minister regarding the scope of state property, the term of exercise of the ownership rights and any relevant provisions of the Vtv.

By the Decree No 7/2021. (VI.3.) of NVTNM, the Minister Responsible for the Management of State Property has amended the Decree No 1/2018. (VI.25.) of NVTNM on the appointment of organizations to be entitled to exercise the whole of the ownership rights of the state. As a result of such amendment, the **Nemzeti Védelmi Ipari Innovációs Zrt. has been appointed to exercise in whole the ownership rights of the state as of 4th of June, 2021.**

The shares owned by the Hungarian State were transferred from the securities account of MNV Zrt. to the securities account of Nemzeti Védelmi Ipari Innovációs Zrt. on July 20, 2021.
