



Extract from Resolution No. 200/2022 of the Budapest Stock Exchange Ltd.

The Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000073507) and related derivative instruments** (included in the Annex to this Resolution) **of the issuer Magyar Telekom Telecommunications Public Limited Company** (registered seat: 1097 Budapest, Könyves Kálmán krt. 36.) hereinafter referred to as 'Issuer' on May 17, 2022 from 10:00 **until the end of the "Post Trading phase" on May 17, 2022.**

In the case the final result of the share buyback auction announced by the Issuer is disclosed before the end of the above period of suspension - in accordance with the rules of the Exchange - the Exchange may lift of suspension the Issuer's ordinary shares and related derivatives.

Reasoning

The Issuer published on May 6, 2022 that it will hold a share buyback auction on May 17, 2022 from 10:00 a.m. to 3:30 p.m. and in connection with it information may arise which can influence the exchange rate of the shares of the Issuer during the continuous trading, so the orderly, transparent and fair trading can not be ensured. According to Sections 23.1. and 23.2. of the General Terms and Conditions of the Budapest Stock Exchange, the Exchange may suspend trading in an instrument if orderly, transparent and fair trading can not be ensured as long as it does not hurt the interests of the investors or the orderly operation of the market. The Exchange did not identify such circumstances and decided to suspend trading according to the above.
