



The new composition of BUX and BUMIX as of March 18, 2024

BSE Release - Budapest, March 8, 2024

The Budapest Stock Exchange Plc., based on the proposal of BSE's Index Committee, adopted BSE resolution No. 56/2024 defining the **new composition of the BUX and the BUMIX baskets**.

BUX

The shares of Appeninn will be newly introduced to the basket.

The shares of Delta Technologies and BIF did not meet the criteria for being listed in the index, but since it was the first time – according to Point 3.3.6.1 of the Manual of Hungarian Indices – their shares will stay in the index.

Based on the above, the new BUX index will contain the following 17 equities as of March 18, 2024: 4IG, Alteo, ANY Biztonsági Nyomda, Appeninn, AutoWallis, BIF, CIG Pannónia, Delta Technologies, Graphisoft Park SE, Magyar Telekom, MASTERPLAST, MOL, OPUS GLOBAL, OTP Bank, PannErgy, Richter Gedeon, Waberer's.

BUMIX

The shares of MBH JZB will be newly introduced to the basket.

Although Zwack Unicum also met the criteria of being included in the index, as Zwack Unicum was being removed from BUMIX at the latest review, based on Point 3.3.5.3 it is not included in the index this time yet.

The shares of NUTEX and AKKO did not meet the criteria for being listed in the index. NUTEX will be removed from BUMIX according to Point 3.3.7.2 a) of the Manual, while AKKO will stay in the index according to Point 3.3.6.2.

Based on the above, the BUMIX index will contain the following 17 equities as of March 18, 2024:

4IG, AKKO Invest, Alteo, ANY Biztonsági Nyomda, Appeninn, AutoWallis, BIF, CIG Pannónia, Delta Technologies, DUNA HOUSE, Graphisoft Park SE, Masterplast, MBH JZB, OPUS GLOBAL, PannErgy, RÁBA, Waberer's.
