Magyar Telekom purchased treasury shares

Budapest – May 22, 2026 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 25, 2026 and on May 13, 2026, for the purpose of shareholders’ remuneration, the Company purchased 275,000 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 2645.69 per share on May 21, 2026. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 56,990,357 treasury shares.
