Magyar Telekom purchased treasury shares

Budapest – June 23, 2026 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 25, 2026 and on May 13, 2026, for the purpose of shareholders’ remuneration, the Company purchased 190,000 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 2766.37 per share on June 22, 2026. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 22,125,782 treasury shares.
