MASTERPLAST Nyilvánosan Működő Részvénytársaság (seat: 8143 Sárszentmihály, Árpád u. 1/A; hereinafter referred to as: „Company”, “MASTERPLAST Nyrt.”) hereby informs the honourable Investors of the following based on shareholder notifications received on 27 August 2026, as well as notifications from executives and legal entities closely related to executives:

Ács Balázs, Vice Chairman of the Board of Directors and Deputy Chief Executive Officer announced that he had transferred 3,877,259 MASTERPLAST Nyrt. registered shares (ISIN code: HU0000093943; hereinafter: "Shares") on 26 August 2026 for the long-term restructuring and consolidation of his private assets as sole settlor for the purpose of fiduciary asset management pursuant to Sections 6:310–6:330 of the Civil Code to a trust management company founded by him, managed by him as sole executive director, and wholly owned by him, AB Invest Bizalmi Vagyon Kezelő Korlátolt Felelősségű Társaság (seat: 8000 Székesfehérvár, Ujlaki u. 2., company registration number: 07-09-037148) under a trust management agreement. The AB Invest Bizalmi Vagyon Kezelő Korlátolt Felelősségű Társaság performs trust asset management as a non-commercial activity in accordance with the relevant Act XV of 2014. Based on the above, pursuant to Section 3(38) of Act LIII of 2017 on Prevention and Combating of Money Laundering and Terrorist Financing, Ács Balázs shall remain the beneficial owner in all respects, as the settlor, beneficiary, and sole owner of the trust management company, with regard to the Shares, the identity of the actual, ultimate and controlling owner does not change as a result of the establishment of the trust structure.

Based on the owner notification submitted by Ács Balázs in connection with the above, the number of MASTERPLAST Nyrt. registered ordinary shares held by Ács Balázs changed from 3,877,259 to 0 on 26 August 2026, and the proportion of his voting rights - by crossing the 20%, 15%, 10% and 5% thresholds - changed from 20.14% to 0%.

The AB Invest Bizalmi Vagyon Kezelő Korlátolt Felelősségű Társaság (seat: 8000 Székesfehérvár, Ujlaki u. 2., company registration number: 07-09-037148; represented by: Ács Balázs, managing director), as a shareholder, announced that on 26 August 2026 it acquired 3,877,259 MASTERPLAST Nyrt. registered ordinary shares, thereby changing the proportion of its voting rights - by crossing the 5%, 10%, 15% and 20% thresholds - from 0% to 20.14%.

Based on the management announcement of Ács Balázs and the notification of AB Invest Bizalmi Vagyon Kezelő Korlátolt Felelősségű Társaság, as a legal entity closely associated with Ács Balázs, Vice Chairman of the Board of Directors and Deputy Chief Executive Officer, the transfer under the legal title trust arrangement took place without consideration, outside the place of trading.
